COMMUNITY NEEDS PROGRAM

<u>Arts & Culture</u> - supporting programs which promote creation, engagement, and appreciation of diverse forms of arts and/or understanding of local history (maximum grant size \$10,000)

<u>Environment</u> - education and sustainability, includes climate change mitigation, sustainable agriculture and forestry, water and land conservation <u>(maximum</u> <u>grant size \$5,000)</u>

<u>Human Services</u> - needs and social service programs (<u>maximum grant size</u> <u>\$10,000</u>)

<u>Senior Dances</u> – promoting social interaction through music and dancing (<u>maximum grant size \$10,000</u>)

<u>Seniors and People with Disabilities</u> – supporting programs providing direct services for individuals (<u>maximum grant size \$10,000</u>)

2020 WOMEN'S LEGACY FUND



Compelling facts from the 2020 What Do Women Need? report:

- •Chronic sadness in teenage girls continues to escalate with 48% of 11th grade girls stating they felt sad and/or hopeless for every day for at least 2 weeks last year.
- •Women's wages continue to fall behind men's wages.
- •Childcare costs continue to rise while availability of childcare dwindles.
- •Latinx families are nearly 3 times more likely to live in poverty than non-Hispanic families and 35% of Latina householders with no husband preset live in poverty
- •Senior women represent 20% of our population and availability of care is a growing issue.

2020 WOMEN'S LEGACY FUND PRIORITIES

Girls Mental Health

 Examples: Self-care, chronic sadness, addressing bullying and harassment, internet safety

Women's Financial Stability

 Examples: Financial literacy & education, economic independence, support for Latinas, income disparity, food security, senior support, housing stability



GROWING TOGETHER: AN LGBTQ FUND

Funding is available to support top priority issues and service needs:

- Anti-LGBTQI Violence
- Housing Discrimination
- Civil Rights/Advocacy
- LGBTQ Supportive Mental Health Services
- Bullying/Harassment/Discrimination
- Youth Services
- Capacity Building for nonprofit agencies providing services for the LGBTQ community
- Single year grants will award grants up to \$5,000
- Two-year grants will award grants up to \$10,000



JANSSEN YOUTH & YOUTH SPORTS

Support programs that enrich the lives of local youth and ideally reflect the Search Institute's 40 Developmental Assets

Preference on direct services costs.

Due March 2, 2020 Maximum Grant Size: \$5,000







OPPORTUNITY TO THRIVE

Organizations utilizing a Family Advocate or case manager to develop and track a client's self-sufficiency plan

Demonstrated ability to administer and monitor a hardship assistance fund

One-time assistance that will make a significant difference in removing a barrier or hurdle to self-sufficiency

Award amount: Up to \$5,000

BUILD Small grants program



BUILD: Building Unity, Infrastructure, Leadership and Development

- Agencies with a \$500,000 and below annual operating budget
- Capacity building
- Capital equipment improvement
- Maximum grant size \$5,000
- Two Cycles will be available in 2020 (spring and fall)

PROGRAM NARRATIVE

Develop a strong narrative summary

Avoid technical language

Match your project to the purpose of the funding opportunity



REQUIRED ATTACHMENTS



There are four required documents:

1. Project Budget

2. Organizational Operating Budget

3. Current Board of Directors

4. Major and current sources of funding
